ENGINEERING STAFF REPORT (as of October 12, 2022)

CONSTRUCTION PROJECTS

- a. Secondary Clarifier 3 Rehabilitation Project (TNT Industrial)
 - Staff is working with TNT to schedule mediation for grout floor failure in November
- b. WWTP Emergency Generator Project (CalElectro)
 - Closeout agreement approved by Board on October 6. Project is complete.
- c. Luther Pass Tank 2 Replacement (TNT Industrial)
 - The District received one stop notice during the filing period, and has notified TNT
 - Staff has scheduled a meeting with TNT on October 18 to discuss liquidated damages
- d. Rocky 1 Waterline Replacement Project (Haen)
 - Haen completed as-directed extra work at Cold Creek Trail
 - Haen is working to complete as-directed extra work for Bijou Center manhole, before closeout process begins
- e. Blower Generator, Secondary Clarifiers 1/2, and Tank Backup Power (Vinciguerra))
 - Staff continues to request escalation impacts from VC for constructing two clarifiers in 2023, with no formal response
 - Construction of radio tower and tank batteries is continuing
- f. Paloma Well Rehabilitation (Zim Industries)
 - Contractor mobilized October 11; Staff is waiting for new project schedule
 - Customer notifications for project going out October 12
 - Staff will coordinate with CTC for development water discharge
 - Contractor has not responded to directive for South Upper Truckee Well work, so Staff will look for another solution
- g. Tahoe Keys Pump Station Rehabilitation Project (T&S Construction)
 - Expect to complete backfill and paving in roadway prior to October 15, but excavation around wetwell and meter vault will remain open as work continues
- h. Bowers & Bijou 2/3 Waterline Replacement Projects (Vinciguerra)
 - Board approved Notices of Completion on September 15
 - Stop notice filing period ends on October 22
- Keller Heavenly Phases 1, 2 and 3 Project (White Rock)
 - Board approved Notice of Completion for Phase 1 on October 6

- Factory coated tank panels have been plagued with coating problems; contractor is addressing the issues
- View Circle waterline replacement completed October 11
- Contractor is helping out URS with relocating a sewer lateral out of Angora Creek
- j. Tanks Touchup Project (Topline Engineers)
 - Forest Mountain tank controls could not be completed in time to touch up tank in 2022
 - Staff is reviewing final change order request and preparing to close out project
- k. Tallac Creek Sewer Crossing (Haen Constructors)
 - All permits received as of October 6, and contractor has begun work
 - Expect work to be out of the water by mid-November if weather cooperates
- I. Black Bart Waterline Replacement Project (Vinciguerra)
 - Three bids received on September 20; low bid below engineer's estimate
 - Board authorized award on October 6; contract in process

PLANNING/DESIGN

- a. Groundwater Sustainability Agency
 - Interim Groundwater Program Manager: Staff has recruited Sachi Itagaki of Kennedy Jenks to provide a proposal to serve in this capacity through June 30
 - Staff has begun discussions with CTC regarding monitoring groundwater use impacts on dependent ecosystems; CTC is interested in coordinating with STPUD, potentially with funding; DRI is preparing a proposal for Staff to submit to CTC
 - b. Al Tahoe/Bayview Backup Power & Well Rehabilitation Project (Consultant: Kennedy Jenks)
 - Consultant submitted final Alternatives Analysis on October 7
 - Consultant scheduled to survey site and power route, and pothole on November 1
 - c. Bijou Pump Station Project (Consultant: WSC)
 - 30% Design Review Workshop held on October 11
 - d. Luther Pass Tanks Rehabilitation Project (Consultant: Bayez and Patel)
 - Board approved Task Order amendment on October 6 for Tank 1 design support
 - e. Bijou 1 Waterline Replacement Project (Consultant: NCE)
 - Staff met with Consultant to discuss 50% comments on October 3
 - f. Upper Truckee Pump Station (Consultant: Carollo)
 - Board authorized project for bidding on October 6; project expected to advertise October 14
 - g. Future Waterlines
 - Staff completed Engineering Report for first of two SRF Applications
 - Board authorized survey work for Lake Tahoe Blvd area projects on October 6
 - h. Water System Asset Management Projects
 - Well Performance Monitoring: Pumps began 2022 testing with Bayview, Al Tahoe and Bakersfield complete
 - d. Sewer System Asset Management Projects
 - WWTP Condition Assessment (Consultant: Water Systems Consultants): HDR corrosion specialists completed inspections of concrete boxes, supported by Ops, HM and URS
 - Snowpack and Sewer Flow Monitoring Program (Consultant: Carollo): Staff has visited sites to change batteries and identified two sensors to be replaced before winter

OTHER

- a. Luther Pass Pump Replacements
 - Board authorized purchase of replacement bases for Pumps 1 and 2 on October 6

- b. Tahoe Keys Water System
 - Staff scheduled to present results of Task 1&2 to Keys Board on October 19
 - Consultants for Task 3 scheduled to interview November 1
- c. Community Project Support and Interagency Coordination
 - Staff scheduled to meet with City and SW Gas on October 25 to coordinate CIP
 - Staff scheduled to meet with County and SW Gas on October 26 to coordinate CIP
 - District was copied on a letter from EID to El Dorado County citing concerns with new slurry backfill requirements; EID is looking for the District to weigh in with Tahoe concerns
 - Staff participated in a design discussion with USFS, NHC and GeoSyntec on September 20; investigating opportunities for coordination with future Baldwin sewer work
 - Board approved an easement for the CTC at Martin Well Site on September 15
- d. WWTP Solar Project (Staten)
 - PPA posted for public review October 6, in advance of public hearing on October 20
 - Staff will present major modifications to PPA terms at October 20 Board Meeting
 - Solar AdHoc Committee scheduled to meet October 18
 - Staff is working with CASA representatives to schedule a meeting with CPUC regarding 1MW limit
- e. Engineering Staffing:
 - The Board authorized hiring a new Senior/Associate Engineer and new CAD Analyst on October 6
 - Staff will return Spring 2023 to revisit request for new Engineering Inspector and Staff Engineer
 - Water Resources Manager: This posting has expired, and will be renewed concurrent with a Senior/Associate Engineer position
 - Cross-Training for Engineering Inspections will continue through October, before commencing recruitment for Project Coordinator replacement
 - Staff is working with a recruiting firm to prepare marketing materials prior to advertising positions
 - Asset Management Analyst: Four candidates will be interviewed October 14
