# ENGINEERING STAFF REPORT (as of June 9, 2021)

### **CONSTRUCTION PROJECTS**

- a. Luther Pass Tank No. 2 and Site Valving (Contractor: TNT Industrial)
  - Tank No. 2 reconstruction has commenced
    - Expect erection to take four weeks
  - Defective sleeve valve body was replaced and tested on June 7
    - This valve failed the pressure test too
    - Leak in valve body
    - Investigation in progress
- b. Secondary Clarifier No. 3 Rehabilitation Project (Contractor: TNT Industrial)
  - Schedule for installation of new communications tower at the WWTP is in jeopardy due to delays in TRPA permit review
  - Clarifier No. 3 is offline
    - Construction is progressing

- c. Rocky 2 Waterline Replacement Project (Contractor: Haen)
  - Stop Notice Period ends on July 2
  - Staff will bring Closeout Agreement and final Change Order (if any) to Board on July 15
- d. Rocky 1 Waterline Replacement Project (Contractor: Haen)
  - Contractor is progressing with Rocky 1 Waterline installation and planning for Mackedie
- e. Keller Heavenly Phase 1 Project (Contractor: White Rock)
  - Demolition work at tank site has commenced
  - Staff expressed concerns over shut-down of Upper Saddle Zone due to ongoing water quality issues
  - Extra Work a tank bypass will be added in this phase to allow Upper Saddle Zone to stay in service
- f. Blower Generator, Secondary Clarifiers No.'s 1 and 2, and Tank Backup Power (Contractor: Vinciguerra))
  - Partial Notice to Proceed issued June 10
    - Excluding mobilization for Blower Generator and Secondary Clarifiers and any work on Tank Backup Power
  - Pre-construction meeting planned for week of June 14
  - Staff is working with contractor to value engineer Tank Backup Power Scope of Work
    - If savings cannot be found, this work will be removed from the Contract
  - Mobilization for Blower Generator is on hold pending FEMA environmental clearance
  - Awaiting Secondary Clarifiers funding
    - \$2.25M FEMA grant and State Revolving Fund (SRF) Loan
      - Expected by end of June
- g. Diamond Valley Ranch (DVR) Siphon Repair (Contractor: Christian Brothers Lining)
  - Liner being prepared for installation in late June
    - One day to complete

### PLANNING/DESIGN

- a. Groundwater Management Planning
  - South Y PCE Plume
    - Staff seeking collaboration with Lukins Brothers Water and Tahoe Keys to seek Prop 1, Round 3 implementation project funding
    - Sustainability Advisory Group Meeting scheduled for June 30, 2:00-4:00 pm
      - Topics for discussion include:
        - Depletion of Interconnected Surface Waters (ISW)
        - Sustainable Management Criteria
        - o TVS Subbasin Implementation Plan Projects
- b. Paloma Well Rehabilitation
  - No bids received at May 14 bid opening
  - Staff revised bid documents after talking to three potential bidders
    - Re-advertised Project on June 8
  - Virtual pre-bid meeting scheduled for June 15, 11:00 am
  - Bid opening scheduled for July 7

- c. Tahoe Keys Pump Station (Consultant: Carollo)
  - A bid alternate was added to scope to allow use of an unlined pre-cast polymer concrete instead of pre-cast concrete with liner
  - Bid opening pushed to June 23
- d. Keller-Heavenly Improvements Project (Consultant: Farr West)
  - Virtual mandatory pre-bid for Phase 2 Project held May 25
    - Seven potential bidders attended
  - Phase 2 bid opening scheduled for June 29
  - Proposal for Amendment to Phase 2 design services approved by Board on May 20
- e. Urban Water Management Plan (Consultant: Kennedy Jenks)
  - The Draft 2021 Plan is posted on the District website and will be brought to the Board for adoption on June 17
- f. Tanks Asset Management
  - Bids opened June 3
    - Four bids received
  - Apparent responsive, responsible low bidder is Top Line Engineers of Hayward, CA
  - Recommendation for award to Board on June 17
- g. Future Waterlines

- Staff is proceeding with survey and plan development for Pioneer Trail and Herbert Walkup Waterline Projects in support of potential grant funding opportunities
- h. Water System Asset Management Projects
  - Water Station Electrical Condition Assessments:
    - Business Case Summaries (BCS) review meeting held June 9
  - Artificial Intelligence (Consultant: Baseform)
    - Staff is preparing presentation to Operations Committee in June
  - Satellite Leak Detection
    - District signed Contract with Utilis
    - Expect results end of May
  - Water Station Backup Power
    - Staff has prepared an application for FEMA Mitigation Funds for a backup generator capable of powering either Al Tahoe Well or Bayview Well from the Al Tahoe site
  - Water Crossings Condition Assessment
    - Being performed in conjunction with Sewer Crossings Condition Assessment
  - Cathodic Protection Pilot Study
    - Consultant returned to hook up pilot system
      - o Initial results show 4 of 11 anodes are discontinuous with main
      - Evaluating causes and effects
- i. Sewer System Asset Management Projects
  - WWTP Condition Assessment (Consultant: Water Systems Consultants)
    - Business Case Screening (BCS) sheets for electrical and piping being finalized
      - Consultant is proceeding with preparation for structural evaluation by end of June
    - Sewer Station Electrical Condition Assessments
      - BCS in progress with Water Stations

- Recycled Water Strategic Plan (Consultant: TBD)
  - Two proposals received on May 24 are in review
    - $_{\odot}$  Expect to bring recommendation to Board on July 15
- Sewer Crossings Condition Assessment (Consultant: TBD)
  - Request for Proposals advertised May 25

     Proposals due June 18

# 7. <u>OTHER</u>

- a. Luther Pass Pump Replacements
  - Factory testing underway with expectation for pumps to ship week of June 14
  - Expect new 700 hp pumps to be delivered by end of June
- b. Tahoe Keys Emergency Supply
  - Staff has prepared a Request for Proposals (RFP) Consultant Support for system evaluations and forwarded to Keys for review
    - RFP will be sent to three consultants familiar with District water system
  - Staff has prepared a Reimbursement Agreement to cover District costs back to May 3
    - Expect this to be approved by Keys at their June 16 Board meeting
- c. WWTP Solar Project
  - WWTP utility power consumption charges increased by 31% to 11.7 cents/kWh
    - Improving significantly the financial analysis for the proposed Solar Project
  - Staff continues to work with CORE/Prostar and Optony to prepare the Power Purchase Agreement (PPA)
  - CORE/Prostar is drafting applications for the District to submit to Liberty Utilities for the new solar system
  - Ad Hoc Committee met June 7 to discuss Solar Project progress
    - Expect PPA to be brought to Board for consideration in August
